After many years of advocating for additional resources to more effectively serve residents of Sussex and Warren county, we are pleased to announce the opening of our branch office in Hackettstown. The location of the office was selected to ensure that individuals from both counties could access us utilizing the Para-transit systems. The office will be hosting an Open House on Wednesday, May 25th from 3—7pm. I hope you will consider joining us. If you can't join us on the 25th, please stop in at your leisure. The office houses a resource room filled with information about programs and services pertinent to persons with disabilities, we have computers available for the anyone who does not have a personal computer available to them.

Most recently we have received computer equipment and software for individuals who are blind or visually impaired from the Commission for the Blind and Visually Impaired. This equipment and software is available in both our Denville and Hackettstown locations. The computers are equipped with JAWS, Kurzweil, Zoom text, screen readers, CCTV and a scanner to enable individuals to who have visual impairments to independently access the web, review important documents and other computer related tasks they otherwise may not have access to. If you are interested in using the equipment and need transportation to the office, please contact the staff and they will assist you in making the arrangements.

DAWN CENTER FOR INDEPENDENT LIVING OFFERS HOME MODIFICATION PROGRAM FOR INDIVIDUALS WITH SPINAL CORD INJURIES LIVING IN MORRIS, SUSSEX AND WARREN COUNTIES

DAWN Center for Independent Living is pleased to announce the availability of funds made possible through a grant from the Craig H. Neilsen Foundation. The grant will provide home modifications to people with spinal cord injuries living in Morris, Sussex and Warren Counties. Priority will be given to persons at risk of institutionalization if modifications are not made to their home. Medical and financial need must be demonstrated. Types of modifications may include but not limited to ramps, widening of doorways, raising countertops, grab bars, floor level showers and stair glides. Applicants must provide two cost estimates of the work to be done as well as before and after photos. The amount available per recipient will average \$2,000 - \$4,000 on a first come, first serve basis.

Established in 2002, the Craig H. Neilsen Foundation is a private foundation dedicated to supporting cutting-edge research to find a cure for paralysis due to spinal cord injury (SCI) and innovative rehabilitation programs to improve the quality of life for those living with SCI. Mr. Nielsen, himself a quadriplegic for 21 years until his death in 2006, recruited experts in the SCI community to peer review all grant requests for scientific and clinical research, post-doctoral fellowships, and quality of life program grants.

ADVANCING OPPORTUNITIES HOUSING REHABILITATION PROGRAM

The Advancing Opportunities Housing Rehabilitation Program serves individuals living with the family who are registered with the Division of Developmental Disabilities (DDD) in Morris, Sussex and Warren Counties. Services provided include: 1.) Advice on how to make a home safe and accessible: one of our Rehabilitation Technicians will come out to the home, meet with the family and help them understand their options. 2.) Funding (up to \$2,000) to help pay for accessibility modifications.

To receive services from the Housing Rehabilitation Program consumers should: 1.) Contact their DDD manager; 2.) Case manager **must** send a referral for eligible families to Advancing Opportunities Assistive Technologies Services Department; 3.) Advancing Opportunities will arrange a home visit upon receipt of referral; 4.) Advancing Opportunities will complete an assessment report and send it to the family with a copy of their DDD case Manager; 5.) The family is responsible for

obtaining estimates of work or equipment specified in the report.

AMENDMENTS ACT DEFINES DISABILITY

The Equal Employment Opportunity Commission (EEOC) final regulations to implement the ADA Amendments Act (ADAAA) which went into effect in 2009, are now available and not available on the Federal Register website at www.ofr.gov.

The regulations are designed to simplify the determination of who has a disability and make it easier for people to establish that they are protected by the Americans with Disabilities Act (ADA). The ADAAA overturned several Supreme Court decisions that Congress believed had interpreted the definition of disability too narrowly, resulting in a denial of protection for many individuals with disabilities. It states that the definition of disability should be interpreted as broadly as possible.

The regulations list a set of principles that guide the determination of whether a person has a disability. For example, the principles state that an impairment doesn't need to prevent or significantly restrict the performance of a major life activity to be considered a disability. Impairments that are considered to be disabilities under the ADAAA are epilepsy, and cancer (if in remission), HIV, diabetes, and bi-polar disorder.

JEWISH VOCATIONAL SERVICES ACCEPTING APPLICATIONS FOR CAREER CAMP 2011

Jewish Vocational Services (JVS) is now accepting applications for its Career Camp 2011 for Teens with Disabilities. Two sessions will be held. The first one will be held from August 1 to August 12, 2011 for students with mobility and cognitive impairments (sponsored by the Kessler Foundation); the second session will be held for students diagnosed with an Autism Spectrum Disorder (sponsored by the Blanche and Irving Laurie Foundation).

The objective of Career Camp is to help prepare students for work, education and training. Career Camp 2011 will provide students the opportunity to engage in vocational activities designed to simulate job tasks and give hands-on experience developing a variety of different job skills. Camp activities will focus on vocational exploration, appropriate work behaviors, and social skills development. Classroom instruction will be interactive and include resume writing, completion of job applications, and practicing interviewing skills. Campers will also take field trips to community employment sites to learn about the range of jobs available in areas such as health care, culinary arts, animal care and horticulture.

Founded in 1939, JVS is a nonprofit community-based organization that provides a broad range of vocational, education, rehabilitation, training, health and human services on a nonsectarian basis to individuals and companies in New Jersey. The mission of the agency is to help members of the community maximize their abilities and potential and become economically self-reliant productive citizens.

Learn how supports and services will be determined for your son/daughter's future once their school entitlement ends at age 21.

The Advocates for Alternatives and New Jersey Developmental Planning Institute will be conducting a survey for individuals eligible for Division of Developmental Disabilities (DDD) services. They will be holding a forum on Thursday June 9, 2011 from 6:00 pm to 8:30 pm at the Morris County Library – Whippany Branch, 30 East Hanover Ave., Whippany, NJ, to clarify the Developmental Disabilities Resource Tool (DDRT). The DDRT is a phone survey used by the New Jersey Division of Developmental Disabilities (DDD) to determine an individual's level of need to provide supports after graduation.

The forum is most appropriate for families who have young adults (14 years of age or older) currently in transition planning from school to adult-life and professionals working with these families.

The forum is an opportunity to better understand the Self-Direction option of DDD Day Services. Examples will be given of individuals and families who are currently self-directing their supports and services. A review of the DDRT will be presented to better prepare participants for the phone survey.

CHRISTIE BUDGET TO CUT \$ 540M FROM MEDICAID FUNDS, TRANSFER PARTICIPANTS INTO MANAGED CARE

Calling Medicaid Spending “out of control”, Governor Chris Christie on Tuesday February 22, 2011 proposed cutting \$540 million from the massive health insurance program for the poor.

New Jersey expects to spend about \$4.4 billion in state and federal funds on Medicaid during the fiscal year that ends June 30, 2011 to cover about \$ 1.3 million of the state’s poorest residents. The program is \$1.3 billion in the red.

Medicaid is a government program that provides free medical assistance for qualified beneficiaries. New Jersey’s Managed Medicaid Program requires most Medicaid – eligible people with disabilities to receive their health care from managed care organizations.

Managed care is a comprehensive approach to providing and paying for high-quality health care services – from routine to emergency - within a coordinated system in a cost - effective manner. The health plans that provide the benefits package for the Medicaid Managed Care System in New Jersey are called Health Maintenance Organizations (HMOs).

People with disabilities found eligible for the program **must** select for their health care with one of the five HMOs that have contracted with the State of New Jersey to provide Medicaid Managed Care services. If they don’t, they will eventually be assigned to one of the HMOs.

COUNTIES TO HOLD TRANSPORTATION HEARINGS

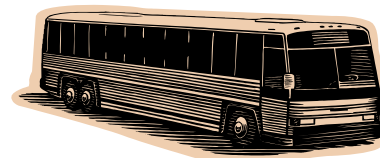
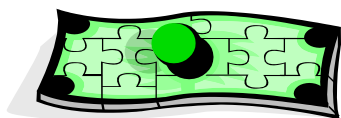

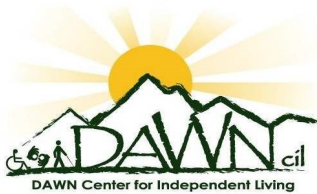
